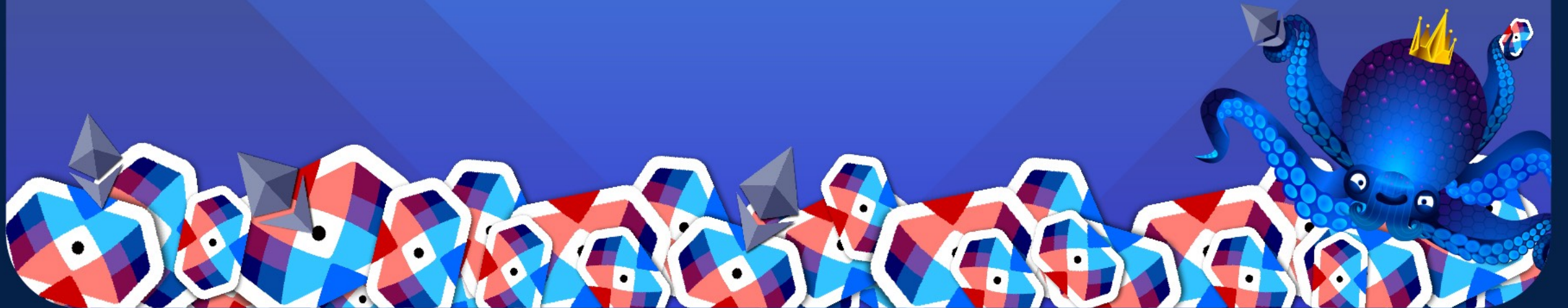

FishExchange supports a variety of blockchain game virtual assets and virtual currencies;

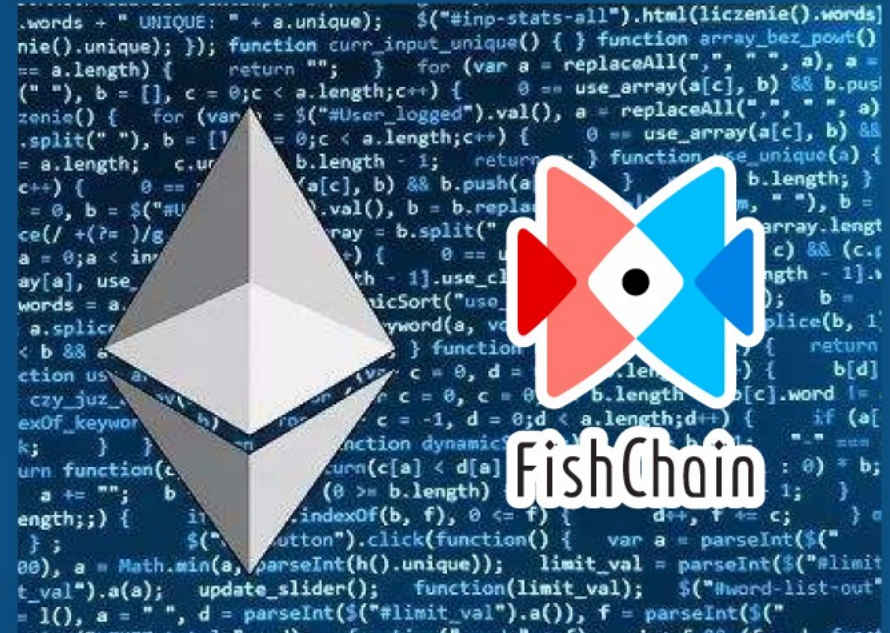

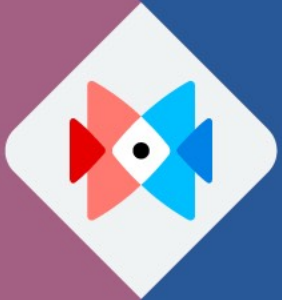
Why Sidechain?

At present, the mature main chain (Ethereum) is designed for the accounting of high-level assets, so it consumes a high gas fee and a considerable confirmation time to complete the transaction. However, the game operation is always high-frequency and low-value, which means it is unable to make ends meet if it operate the game on the mainchain. Therefore, FishChain uses the side-chain base and stores the mainchain assets on the server in a proxy manner where users can withdraw their assets to the mainchain at any time. This not only ensures the security of the assets, but also minimizes operating costs.



Game Crypto-asset Trading Platform

The FishChain trading platform is designed to serve the blockchain game ecosystem and provide game developers with an open and transparent game crypto-asset trading platform. Different from the traditional trading platform, FishChain not only provides the game crypto-asset trading feature, but also provides pre-sale, auction, community and other IGO features to facilitate pre-heating and continuous operation of games.

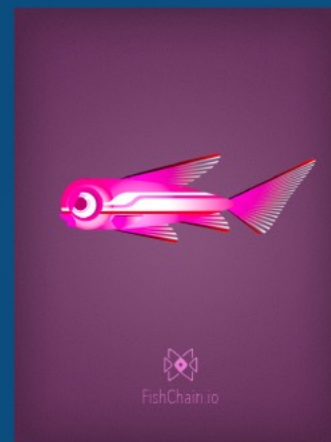
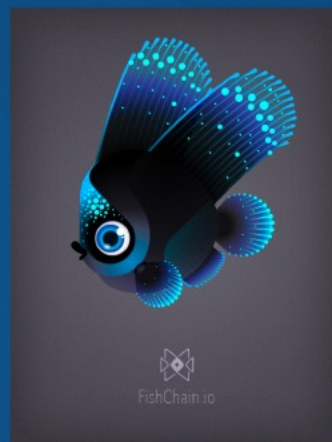
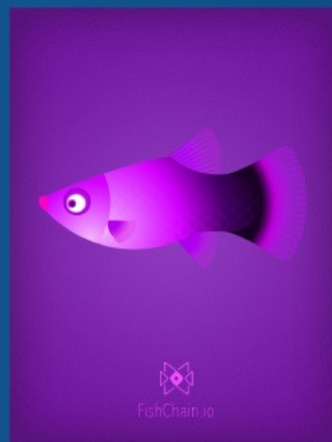


Trading Platform Features——Pre-sale, Auction

The Combination of the Token Economy Model and the Traditional Game

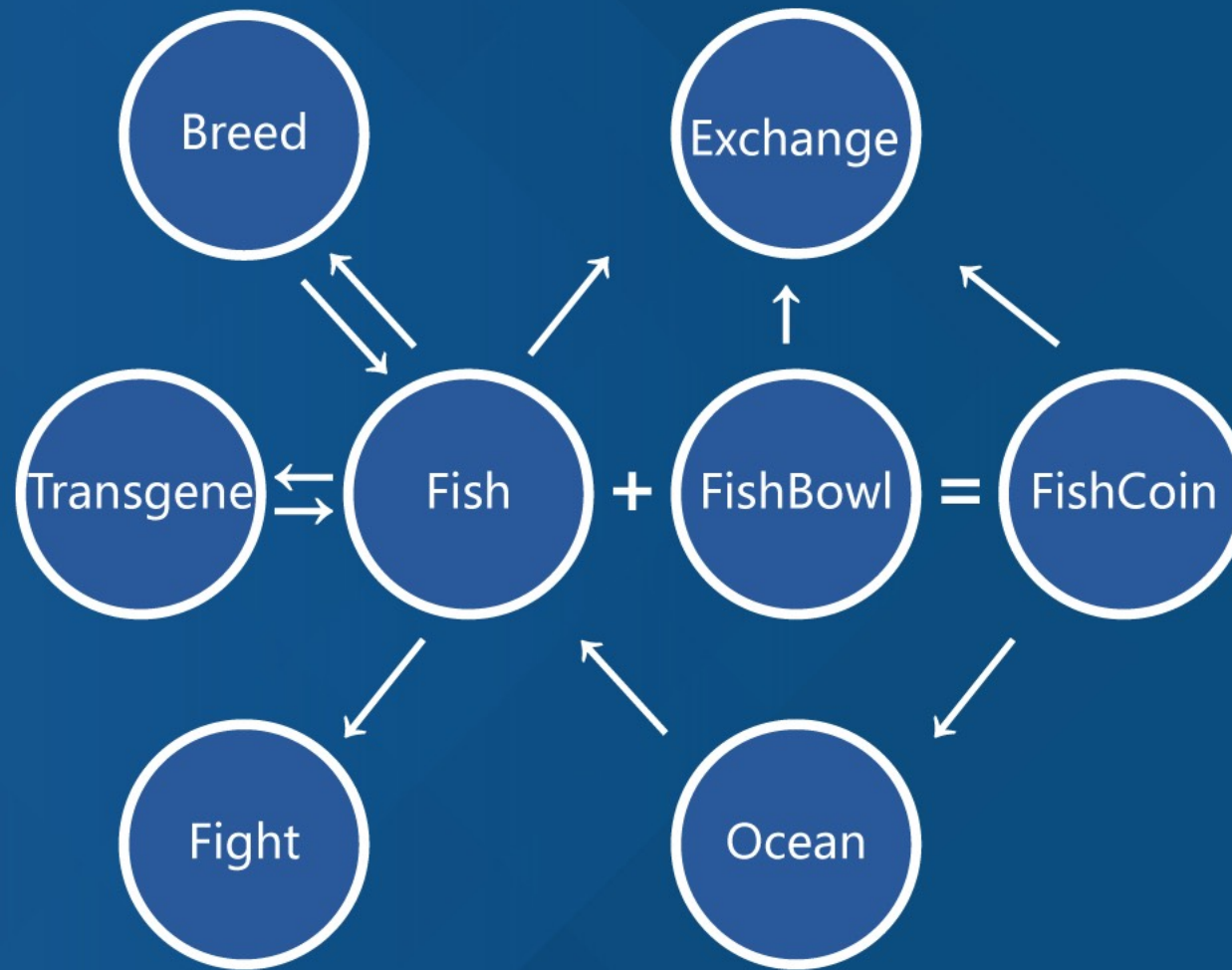
The FishChain inline game is not so much a game as it is a combination of a token economy model with a game.

FishChain designed a token with an inside and outside double market—FishCoin. Inside the game, FishCoin is the only currency in circulation. The purchase of system items, trading, commissions, etc. all take place with FishCoin's, and this is a market that belongs to players. In the external market, FishCoin can also trade with other valuable mainstream currencies on the market and this part is for investors. The two parts are connected by FishCoin to form a complete ecosystem.

Refactoring the economic model of the game and making the game assets truly belong to the players is FishChain's mission.

A total of 20,000 FishBowls are issued in the FishChain. Each FishBowl has a unique number from 1-20000, and the FishBowl will never increase. The FishBowl can be classified according to their appearance: green, blue, pink, purple, black, white, gold, and special activity FishBowl.

Green, blue, red, pink, purple is the most common shape with a common number and small capacity. If you put into the fish that has the same color with the FishBowl, there will be a slight bonus in computing power. Black and white and special activity FishBowl is less in quantity and medium in capacity. (some special FishBowls are unique in shape, such as the World Cup themed Fish-Bowl). They will increase slight computing power for all fishes and increase a large number of computing power for black and white fishes. The golden FishBowl is the best one, with a large capacity and a large number of computing power bonus for all fishes.

In addition to the practical value of producing FishCoins, the special activity FishBowl also has its own value-added potential because of its uniqueness and scarcity.



Fish


The system allocates a certain amount of FishCoins to the game according to the number and computing power of the fish. Put the fish to the FishBowl to get FishCoins. The higher the computing power, the more FishCoin shares will be allocated.

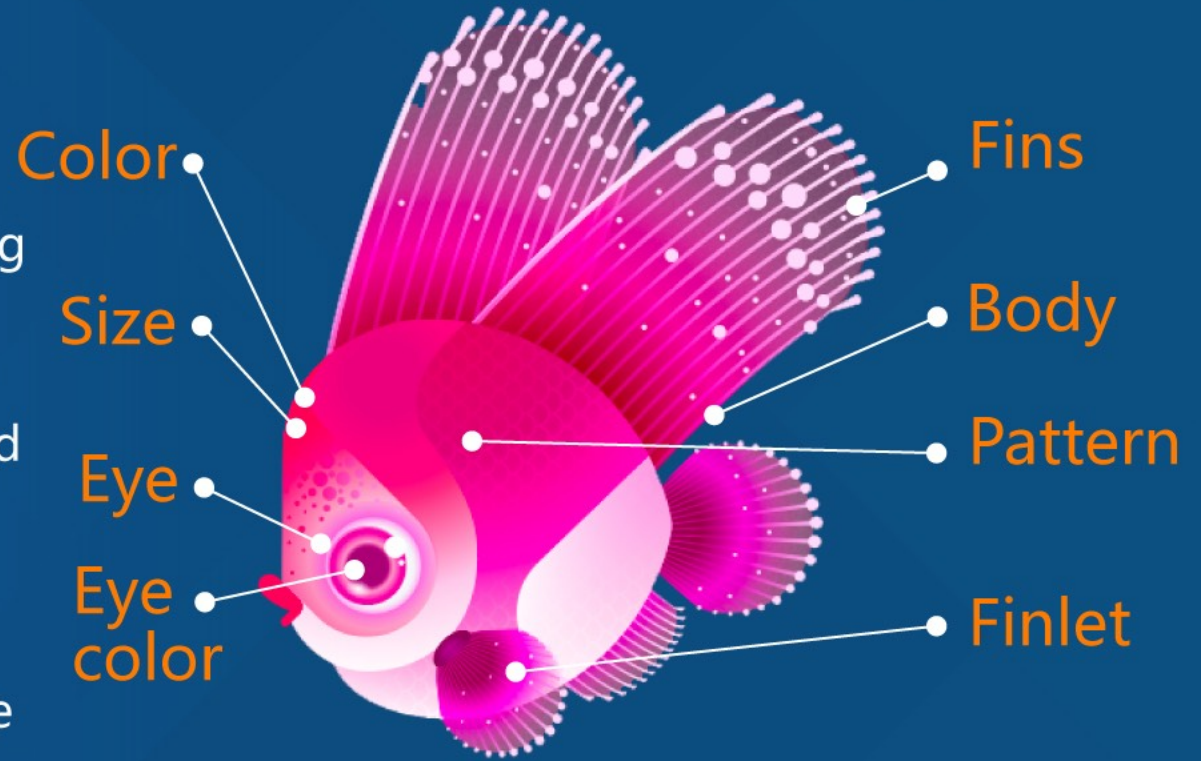

Gene Combination

Each Fish is made up of genes. Unlike other gene combination animal games, Fish can support all combinations of genes while owning distinct appearance. That's right, even if in different appearance, the Fish is still arbitrarily multiplied, and there will be no strange combination.

Currently, eight gene positions have been published: Size, Color, Body, Pattern, Eyes, Eye Color, Finlet, Fins.

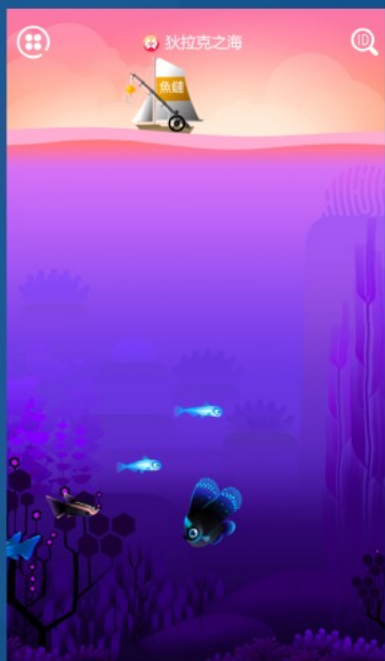

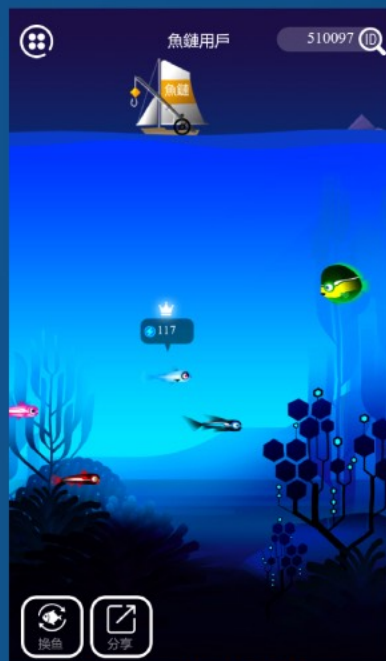
Official Fishing: The official determine the price of each fishing. The fish is caught randomly and there will be a chance to catch fish with new genes and rare fish.

Normal Fishing: Players can put the fish into their own fishing pool, and set the price and number of shots per fishing for other players to fish.

Celebrity Pool: Players with golden FishBowl can open celebrity pool fishing, which is a Fomo3D-like gameplay.

If players have specified fish suits, the corresponding illustration will be opened. If the fish suits are sold, the corresponding illustration will be closed. All the opened illustrations will share the previous day's fee.



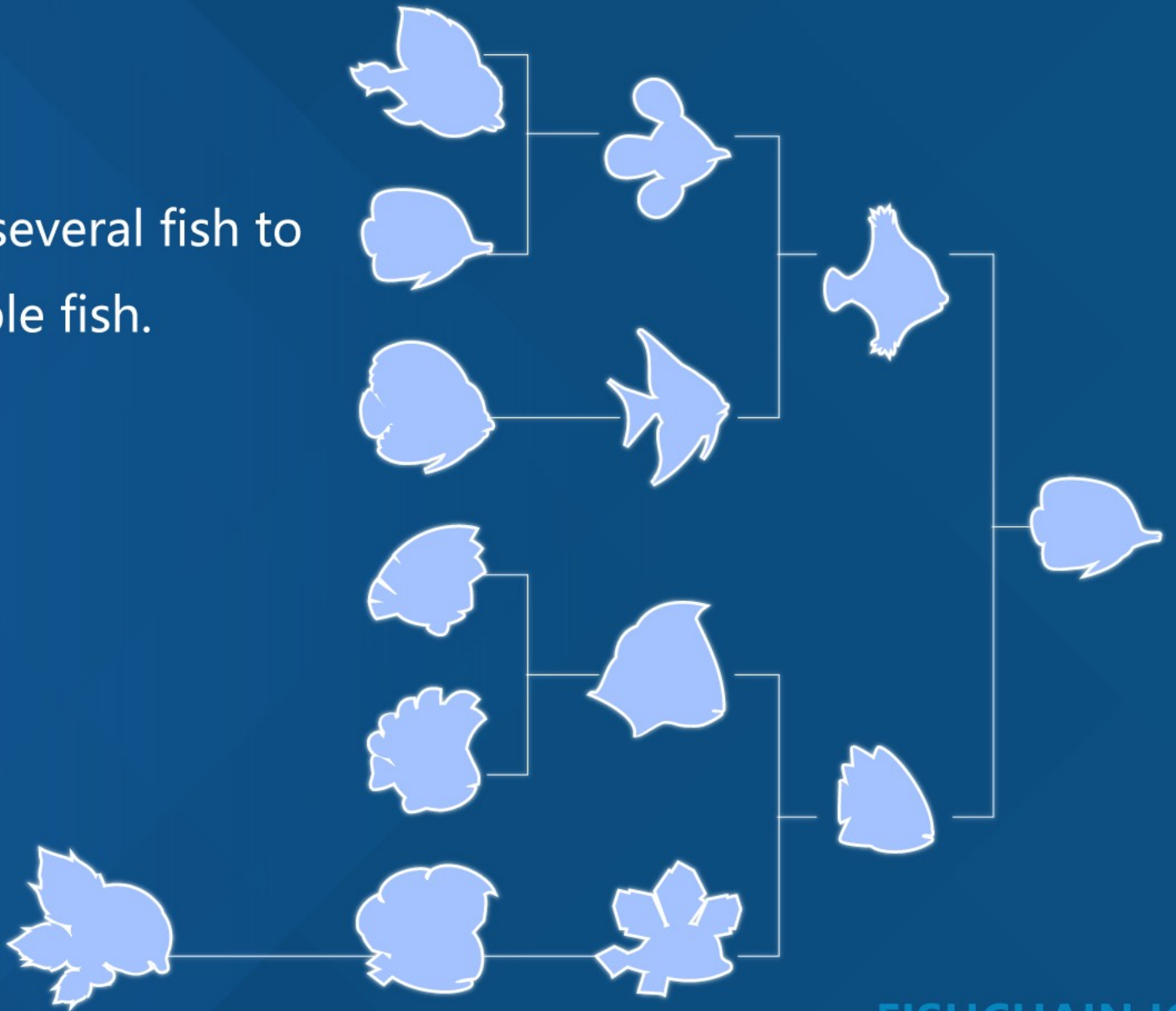
Breeding

If you have 2 fishes, you can try to breed a new one. The genes of the offspring are inherited or mutated by the parents. Each gene position is inherited independently. There is a higher probability of inheriting parents' genes and a smaller probability of mutation. The mutations may be positive (upgrade) or negative (decrease). Fish will enter a cooling period after they complete the breed and they cannot breed in their cooling period. Fish will become older and older as they breed more and more, which means its cooling period will become longer and longer.



Mixing

Players can mix several fish to one more valuable fish.



Fighting

Fighting between Fish from different players is allowed.



Token? Why did FishChain Issue a Token?

FishChain does not want to be a short life week and fast cashing game. Our goal is to build a sustainable win-win ecosystem in the game.

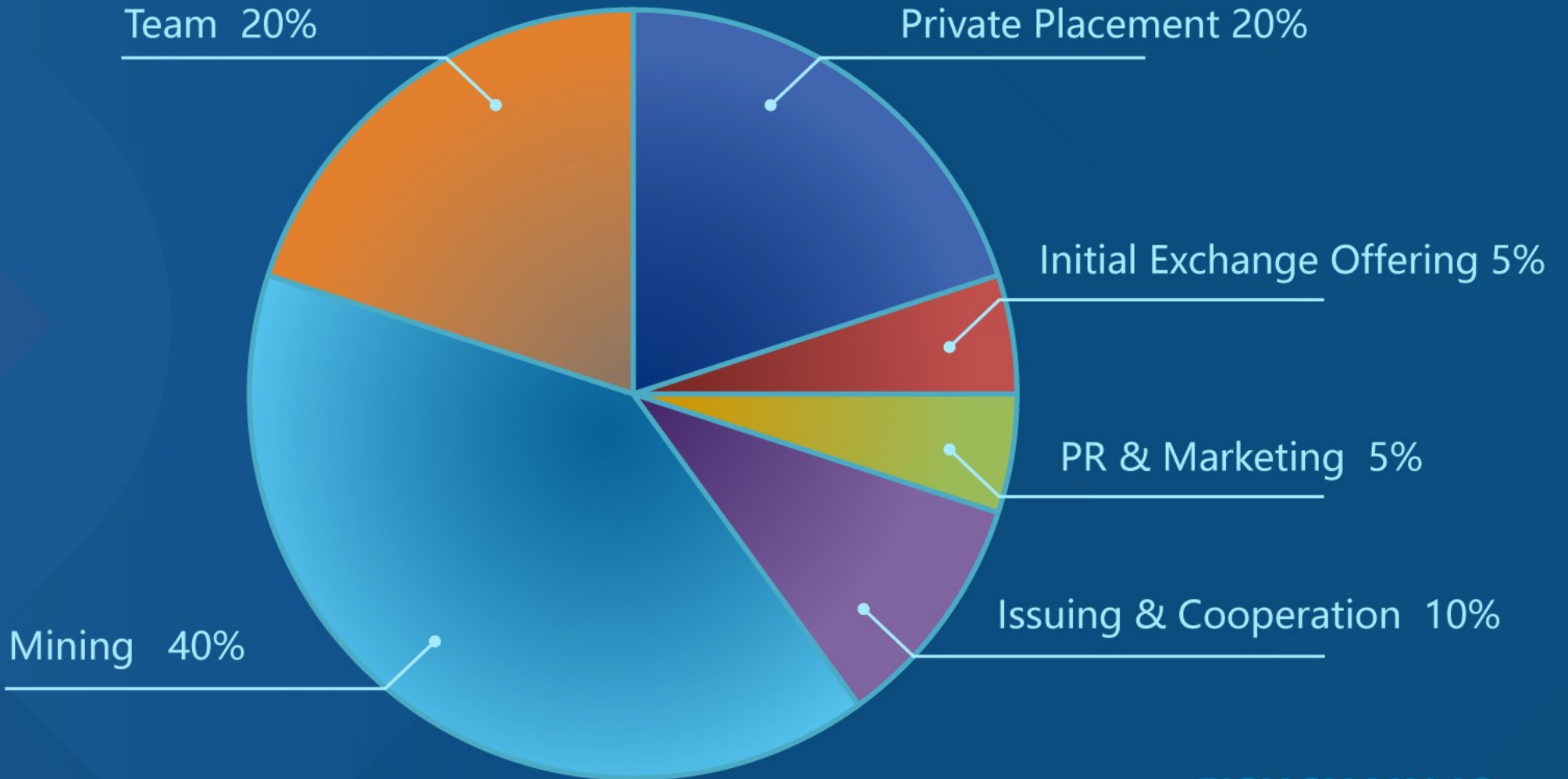
Through the controlled release of token liquidity, we will gradually release a stable internal ecology of the ecosystem formed by the three assets of Fish, FishBowls and FishCoins.

Only in this way can we guarantee the stable value of FishCoin relative to ETH or other mainstream currencies.



Token Plan

Max Supply: 4,200,000,000



TOKEN PLAN 4.2bn FishCoin's will be distributed as follows:

Mining(40%): players owning limited edition FishBowl put the fish in the FishBowl and they have a chance to get FishCoins. The system distributes a certain amount of FishCoins according to the number and attributes of the fish. The total number of FishBowl is limited to 20,000.

Private Placement(20%): only institutional investors with legitimate funding sources can participate. Not for individual investors in Chain or USA. Participator need show KYC. Raised funds are mainly used for game development and marketing. FishCoins for private placement has no lock-up period.

Team(20%): will be assigned to the core staff in the founding team. The core staff are the key personnel in the development of the project. FishCoin lock-up period of 4 years. Releasing 25% each year.

Issuing & Cooperation(10%): used for the operational expenses of the publishers and partners of the game to ensure and maintain the promotion of FishCoin. FishCoins for the issue and the partner lock-up period is one year.

PR & Marketing (5%) : for PR, Media and other Marketing related expenses.

Initial Exchange Offering (5%) : for launching on Games, Exchanges and Marketing to provide the market with liquidity.



Token Appreciation Plan

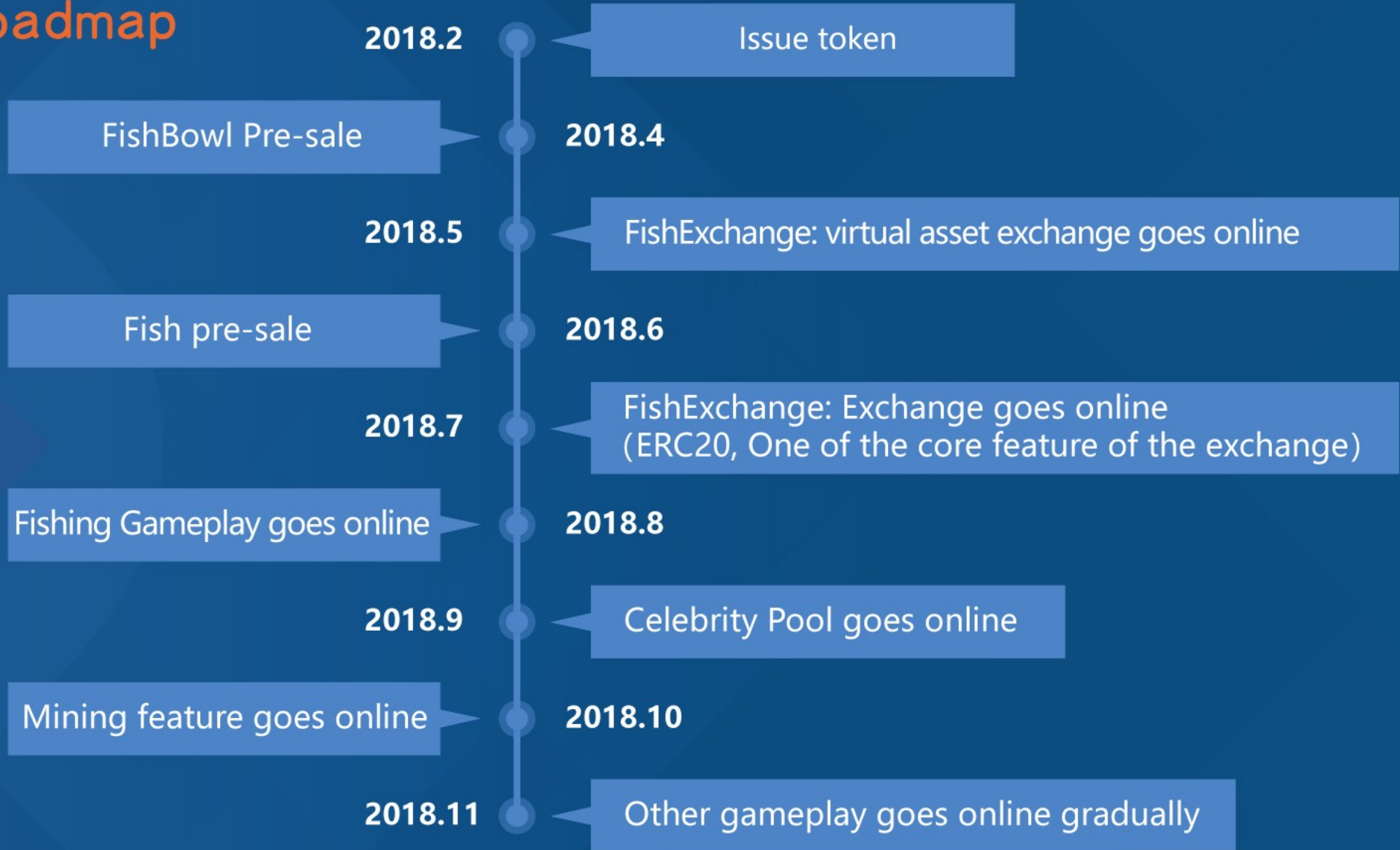
FishCoin In-game trading, spending and commissions can only be paid with FishCoin' s Concerning the trading digital assets for other games, pay commissions with FishCoin' s can enjoy the discount.aFishCoin will be a basic currency in the Exchange, opening */FishCoin trading pairs of all commission income will be destroyed until the remaining 10% of total FishCoin' s .

Fish will have a value anchoring the legal currency. For example, the cost of getting a new fish is 5-10 USD. (forced anchoring through fishing/trading/breeding commission and gas cost on the chain)

The market value of circulation is relatively small ,the token plan is moderately released, and it is convenient for market value management.

LEGAL OPINION RELATING TO SALE OF FISHCHAIN TOKENS ("SALE")

Executive Summary

1. Based on the applicable provisions of the Singapore Securities and Futures Act (Cap. 289) ("SFA"), and references to case law, we are of the opinion that the FishCoins ("Tokens") are unlikely to fall within the definition of "securities" as presently contained in the SFA.
2. Therefore, conducting the Sale is not likely to constitute a regulated activity for the purposes of the SFA, and the Company is likely to be exempted from the requirement to apply for a Capital Markets Services (CMS) licence or to lodge a prospectus with the Monetary Authority of Singapore ("Authority") prior to conducting such Sale.

Introduction

3. We write to render our opinion on the following:
 - 3.1. Whether the SFA applies to the Sale;
 - 3.2. Whether the Tokens fall within the definition of "securities" as prescribed in the SFA, if so;
 - 3.3. The impact on the Company; and
 - 3.4. Whether the Tokens falls within the definition of "stored value facilities" under the PSOA (defined below).

4. Please note that this opinion is limited to Singapore law and is based on our understanding of the nature of the Tokens and the Sale as set out below under **Background and Assumptions**.

Background and Assumptions

5. We have reviewed and exclusively relied upon the following documents for the purpose of rendering this legal opinion:
 - 5.1. The FishChain White Paper found on http://fishchain.io/download/FishChain_Whitepaper_EN.pdf and http://fishchain.io/download/FishChain_Whitepaper_EN.pdf, accessed on 8 March 2018 ("White Paper");
 - 5.2. A draft of the Private Sale Agreement between the Company and purchasers of the Tokens ("Sale Agreement").
6. We have also rendered this legal opinion based on the following assumptions:
 - 6.1. The Company is the sole vendor of the Tokens.
 - 6.2. The Company is a private limited company incorporated in the Cayman Islands.
 - 6.3. The functions of the Tokens will adhere in all material respects to the characteristics as set out in the White Paper.
7. Based on the documents referred to in paragraph 5 above, we have assumed that the sale of the Tokens is "non-refundable under any circumstances" by the Company¹. We have also assumed that the Tokens also do not carry any voting rights or other management or control rights in the Company, and they do not give the Token holders any ownership interests or any right to receive future revenues, profits, shares, equities, securities or any form of participation².

¹ Clause 6 of Part 1 of Schedule 2 of the Sale Agreement. We have not found any language in the White Paper to suggest that the Company will, in any situation, be required to provide a refund to the purchasers. Please let us know if this assumption is not accurate.

² Clause 4 of Part 1 of Schedule 2 of the Sale Agreement. We have not found any language in the White Paper to suggest that the Tokens will come attached with such rights. Please let us know if this assumption is not accurate.

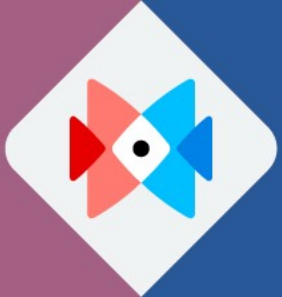

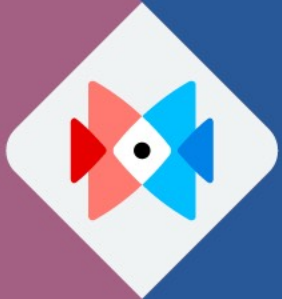

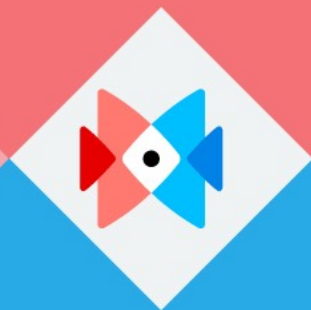
